



**Clayton County Parks and Recreation  
Advisory Board Meeting  
Minutes  
October 30, 2017**

**I. CALL TO ORDER**

Parks and Recreation Director, Troy Hodges introduced new member Dr. Elliott McGlory of Riverdale, GA. Dr. McGlory is a Parks and Recreation appointee replacing the vacated seat of Tod Nichols.

**III. APPROVAL OF PREVIOUS MINUTES**

September 18, 2017 Minutes were provided to the Board for review.

**IV. OLD BUSINESS**

a. Fees Change Policy

Mr. Hodges distributed the Clayton County Parks and Recreation Written Fees and Charges Policy to the Board.

Mr. Hodges is requesting the Board to review the policy and offer any recommendations at the next Board meeting. Mr. Hodges will be presenting the revised Fees and Charges Policy along with the 2018 Fees and Charges Policy to the Board of Commissioners for review, approval, and adoption.

b. Advisory Board Access to Facilities Effective Date

Ms. White reminded the Board to visit a local recreation center to have their ID printed for facility access. Clayton County Advisory Board members are volunteer members of the community without compensation; however, access to recreation facilities is extended to current active Board members to better help accomplish their role as an Advisory Board member.

c. Schedule Date for Tour of Facilities w/ the Board

Ms. White requested the Board compare schedules and select a date to tour the Parks and Recreation facilities. Board discussion identified conflicting schedules and the need for multiple tours due to the number of properties under the Parks and Recreation Department. Other Board members agreed that using their facility ID card to go on their own would be sufficient. After discussion amongst the Board, Mr. Hodges recommended the Board inform his office should they be interested in a formal tour of a park or facility.

d. Advisory Board E-Mail and Business Cards

Ms. White distributed a draft business card script to each Board Member for review and approval. Each member approved or corrected their name, title, and contact information. Parks and Recreation Advisory Board Member business cards will be used to distribute to the community as the Board member interact and seek out public opinion and recommendations. Business cards will be available for Board members at the November 13<sup>th</sup> meeting.

e. Introduction to the Executive Team

In a previous meeting, the Board requested to meet with the Parks and Recreation Executive Team. After today's discussion, the Board agree to meet with the Executive Team in small groups.


