  - Herbert mentioned that his strongest is the Veterans Benefits and a lot of outreach with hiring and ministries. Diane volunteered to get with World Changers to see exactly what they do for the Veterans because that's the church she attends.

- Chairwoman Adams mentioned that Education, Employment and Housing falls under Benefits; we can bring in more people to work on those committees. Herbert said that all three are already covered and taken care of. Chairwoman Adams said she just wants to put all the resources together so that way she can just go straight to the Advisory board and refer them out; she wants to be more effective in helping Veterans who needs help so we're not all over the place. Basically, how can we (Advisory board) refer these Veterans to these organizations you speak of? Herbert knows the lady down the hallway he works at that is familiar with housing and employment is right down the hall from him. He will get contact information for Chairwoman Adams. How can we bring those resources into play?
- Chairwoman Adams wants education on benefits; doesn't want to be misleading and help with the Education portion. The VA handles the education portion. Herbert said there's plenty of information out there and Chairwoman Adams said, that's what we're trying to get to to create on our website for Veterans easy access. Diane suggested to add a link on website page on education but Chairwoman Adams said we don't want to get too entrenched. We're an Advisory Board nothing else nothing more. All we doing is "information and referrals". Just keep it simple. Again, let's just come up with the resources for the website. No person's name just the agency's contact information Example: Department of Labor or Chamber of Commerce and their direct information.
- Diane will connect with Employment and get resources. Herbert will connect with Housing and Education and they will get back with Chairwoman Adams on contacts for website. Herbert said he has all of that in hand (Education, Employment and Housing). Chairwoman Adams said Diane and Chris will handle Employment and Herbert will handle Education in benefits.
- Pearla asked do we already have a website and Chairwoman Adams said no, she
  has spoken to several Commissioners and Detrick for a page on their website.
   Still no response. We need to get on their Agenda to request a page on the
  county's website.
- o RET Col Kathleen Harris, Coordinator of Veterans Treatment Court They are under Judge Robert Mac and meet every Wednesday. This program is for Veterans who are incarcerated or coming up of anything that they were found guilty of. It's a 15 months program, cost is \$1500. Incarcerated Veterans can apply. The other side of the program: Long term program it's an addiction program. They're sent off for a year or so to get a full pledge treatment. Kathleen is also the Coordinator for the Mentors to help out with the participants of the court. They are required to attend a five phase program that is laid out for them. Each participant should have two mentors to help them with the reconnecting of family, medical addictions, communications or anything they need help with. Participants are also drug tested, home visits for drugs and curfews. And the participants have a community project that they

- need to do on last phase. They graduate as well. It's difficult to find females in the program. Georgia has 18 VTC's. It is not sure that this is on the court or Clayton County websites.
- O Kathleen Harris also spoke briefly about the National Association of the Military Black Women; just got through with the conference. They started off with 21 ladies in Virginia (World War II Ladies). In Clayton County, where the chapter is located at 9 different projects going on now JROTC program, senior assistance living program, veterans parade, festivals, talented program, etc. The women history month is in March. Diane will be the contact person to report to the CCVAB. Diane suggested proclamation from the commissioner's and the governor's office. Chairwoman Adams suggested to combine the women history month and the capital veteran visit in conjunction of the veteran of the month: collaborate with the senior vet all in May.
- Veteran of the month Alan Vigil in September, Leo recommended by Ward and Diana suggested Tax Commissioner Terry Baskin and S. Buford – Safety Officer.
- By Laws must be reviewed in the next two weeks; signed off and send to Chairwoman Adams so she can send to the Commissioners get together and have a sign day
- Meeting location and zoom account is needed. Chairwoman Adams is trying to connect with the commissioners to continue on paying rent so we can meet together with other Veterans, board advisors to help out.
- Kenny was going to talk about the budget line item to promote ourselves on website, brochures and business cards, but he was not available.
