The following report represents a summary and recap of major operations and activities that we have completed or are ongoing within Elections and Registration for the month of August 2022 and activities since the last Board meeting.

The priorities were centered on Post-Election Day activities associated with the 2020 June Primary Elections November General & Special Post Election Day request as well as the January 5, 2021 Special and General Runoff Elections, processing voter registration applications, open record requests, the election activities for the Post – General elections, trainings, renovations, pre-election activities associated with the November 2022 election and the rearrangement of elections tasks due to the global pandemic COVID-19.

ELECTIONS

PERSONNEL STAFFING: STAFFING PROFESSIONAL DEVELOPMENT AND TRAINING:

Deadline driven task from the redistribution of daily operations continue to receive priority training which included Staff Training.

ELECTION CENTER ANNUAL CONFERENCE - 2022:

Director Dozier attended the 37th meeting of the national conference held in Denver, CO. Items of discussion included coping mechanisms, cyber security, voter education and communications.

2022 BOARD OF REGISTRATION AND ELECTIONS BOARD RETREAT:

The Clayton County Board of Registration and Elections Board retreat is scheduled on Friday, September 23, 2022 from 9:00 AM – 4:00 PM at the Marriott AC Hotel Atlanta Airport Gateway.

2022 NOVEMBER GENERAL ELECTION:

POLL WORKER TRAINING:

Poll Worker Training is set to start September 21, 2022 and will continue until October 29, 2022.

NOTE: We are seeking to recruit/retain 1,250 Poll Officials to serve. Currently we have 2,000 veteran and new Poll Officials confirmed to work and we are still receiving applications.

There are 50 classes scheduled to host our Poll Officials. Registration will open for scheduling on September 6, 2022. For those that are recruiting it is important that the applications are completed and returned to our office to ensure that the department reports accurately to Human Resources. In order for a potential Poll Official to schedule training they are required to complete their paperwork with Human Resources and must be issued their county employee number prior to registering. These efforts ensure that all Poll Officials are prepared to receive payment for their services.

LOGIC AND ACCURACY TESTING:

Logic and Accuracy Testing is set to commence, Wednesday, September 14, 2022 and will continue until completion.

EARLY/ADVANCE VOTING:

The dates in which a voter can vote in advance of Election Day are October 17, 2022 – November 4, 2022.

EARLY ABSENTEE SCANNING:

Scanning will commence October 24, 2022. The following are dates/times in which the adjudication/duplication Teams will be needed:

- o Friday, October 28, 2022, 10:00 AM
- Friday, November 4, 2022, 10:00 AM
- Tuesday, November 8, 2022, 12:00 PM
- Friday, November 11, 2022, 1:00 PM

These dates/times are subject to change. Should there be a need to adjust we will file and post the proper public notifications as required.

2022 DECEMBER GENERAL RUNOFF ELECTION:

POLL WORKER TRAINING:

There is no requirement for training however, we will continue to meet with our Poll Officials for updates and for those that are interested in practicing, we have options for them to come to the department for additional assistance.

LOGIC AND ACCURACY TESTING:

Logic and Accuracy Testing is set to commence, November 21, 2022 and will continue until completion.

2022 ELECTION YEAR ADVANCE VOTING DATES/TIME:

Director Dozier's recommendations below include expanding Early Voting locations across the county to (10) ten early voting locations to provide more access to our Clayton County Voters to vote in advance of Election Day. Should there be a need for a Runoff, a recommendation to customize early voting locations will be recommended and proposed to the Board of Elections and Registration.

UPDATE: Flint River Community Center and Sonna Singleton Gregory Senior Center cannot provide us with an adequate space at this time. Director Dozier spoke with Director Strawter regarding space and we are working on planning out space in the facilities for the 2024 Presidential Election Year.
